Protection of Personal Data

The Extension School Registration Platform includes a processing of personal data implemented by ESCP Business School (3, rue Armand Moisant, 75015, Paris) which is based on the fulfilment of a contract as defined in b) of 1 of Article 6 of General Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on data protection (RGPD), and on the consent of the persons concerned as defined in a) of 1 of the same Article.

The 'Extension-School Platform' processing operation is implemented for the following purposes:

- Managing applications and the admissions process
- Invoicing and recovery management
- Management of commercial contracts
- Management of subscriptions to general or targeted information emails
- Follow-up of multi-programme training and post-training professional integration
- Carrying out marketing operations and sales follow-up
- Statistics compilation

ESCP undertakes to process your personal data in compliance with the French Data Protection Act no. 78-17 of 6 January 1978, as amended, and the RGPD, and ensures that no personal

information is collected without your knowledge, or transferred to third parties, and that no personal information is used for purposes other than those indicated.

The recipients of the data are the duly authorised employees of ESCP for the sole purpose of dealing with it.

The information collected is kept as follows:

- Data on non-admitted candidates: 2 years from the date of non-admission;
- Data on admitted candidates: 4 years from registration.

You may access your personal data and exercise your rights of access, rectification, limitation and opposition under Articles 15, 16, 18 and 21 of the RGPD at the following address: extension@escp.eu

In the same way, you may exercise your rights under article 85 of law no. 78-17 of 6 January 1978 relating to information technology, files and civil liberties.

To exercise your rights, you must prove your identity by any means. If there is any doubt about your identity, the departments responsible for access rights and the Data Protection Officer reserve the right to ask you for any additional information they deem necessary, including a photocopy of an identity document bearing your signature.

Cookies

A cookie is a piece of data placed on the hard disk by the ESCP sites' server. This data may be stored on the data recipient's terminal in a simple text file that a server accesses to read and record information.

ESCP websites can only read or write their own cookies. These cookies allow ESCP to:
